## **ENVIRONMENT**

- Venue: Heath Ledger Theatre – State Theatre Centre of Western Australia, corner of Roe and William Streets, Northbridge
- Access to the building can be obtained from the main entrance on William Street, the entrance on Roe Street for bus drop-offs or the entrance from James Street.
- A lift provides access to all levels of the building. There is also a staircase inside the building for all level access.
- Wheelchair access is available. Wheelchair seating can be requested through your ticketing agent.
